Parent/Guardian personal data processing information clause

In accordance with Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data (General Data Protection Regulation) (Official Journal of the European Union L 119/1 of 4 May, 2016), the University of Siedlce informs as follows:

1. That the controller of your personal data is the University of Siedlce represented by the Rector, with its seat in Siedlce, at ul. St. Konarskiego 2, 08-110 Siedlce.
2. The controller has appointed the Data Protection Supervisor, whom you may contact by email at iod@uws.edu.pl or by post at the above specified address. DPS may be contacted with respect to all cases regarding your personal data processing by the University of Siedlce and your use of the rights related to the processing of personal data;
3. Your personal data will be processed for the purpose of registration of admission to a university programme and the course of studies of your child/person under care;
4. The legal basis of personal data processing is Article 6(1)(c) GDPR and the provisions of the of the Law on Higher Education and Science of 20 July 2018 (J. of Laws 2023 r., Item 742 as amended) together with its executive acts; and Article 6(1)(e) GDPR because processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller; in the event of processing pursuant to the consent, the basis for processing is Article 6(1)(a) GDPR. Your data may be processed with a view to entering into a Study Organization Contract (Article 6(1)(b) GDPR). Your personal data may further be processed on the basis of the legitimate interests pursued by the controller, i.e., the right to determine, redress and defend claims (Article 6(1)(f) GDPR);
5. Your data will be processed until the time of attainment of the goal set forth in Point 3. Your data will be processed for the period required for your child's/person under care's claim determination, redress and defence, if applicable. In the event of non-admission, the data will be removed from the Online Candidate Registration (IRK), and in the event of admission, the data will be transferred to University IT systems. Your personal data will be retained for a period necessary under the legal regulations and internal acts adopted at the University;
6. Your personal data will not be disclosed to third parties, except for entities authorized under the law; Staff members authorised by the controller and admissions committee members will have access to your data.
7. The provision of personal data is voluntary; however, it is necessary to attain the goal specified in Point 3;
8. You have the right to access the contents of your personal data; the right to rectify them, if they are not accurate; to remove them, limit their processing, and to data transfer - in cases provided for by the law; to object the processing of data; to withdraw your consent at any given time without any impact on compliance with the right to process which had been granted prior to consent withdrawal;
9. You have the right to lodge a complaint with the President of the Office for the Protection of Personal Data when you consider that the processing of your personal data violates the provisions of the general regulation on the protection of personal data.
10. Your data will not be processed by automated means or profiled.
